



G3 Farmers Equity Plan Eligibility Certificate



[To be completed by all Farmers who are eligible for Units]

The undersigned (the "Farmer") has or intends to enter into a contract for the delivery and sale of grain to G3 Canada Limited ("G3") which, under the terms of the G3 Farmers Equity Plan, may entitle the Farmer to receive units of the Farmers Equity Trust (the "Trust") in the event that the Farmer is determined to have met the criteria for eligibility. In signing this Eligibility Certificate (the "Certificate"), the Farmer acknowledges and confirms having received a copy of the disclosure information regarding the G3 Farmers Equity Plan entitled *Important Information about the Farmers Equity Trust and the G3 Farmers Equity Plan*, which accompanies this Certificate and has been posted on both the website of the Trust at www.farmersequitytrust.ca/farmers-equity-plan, as well as that of G3 at www.G3.ca.

The Farmer represents and warrants to G3 and the Trust that:

- A. The Farmer is an individual, corporation, partnership or other entity or organization engaged in the production of grain, or entitled to grain produced by a farmer operating a farming business, and is resident in one of the Provinces of Manitoba, Saskatchewan, Alberta or British Columbia.
- B. The Farmer is not a "tax exempt person" as that term is defined under section 149 of the Income Tax Act (Canada).
- C. The Farmer has carefully read and understands the terms, representations, warranties and acknowledgements contained in the *Important Information about the Farmers Equity Trust and the G3 Farmers Equity Plan*, and confirms that all are accurate and true.

The Farmer acknowledges that non-residents of Canada and tax exempt persons are not entitled to receive or permitted to hold units of the Trust, and any issue or purported transfer of units to such a person shall be deemed to be void. Upon execution of the Certificate, the Farmer will be deemed to have made all of the representations set out above and certifies the accuracy of all such statements. The Farmer further undertakes to notify G3 and the Trust of any changes to the information provided herein and authorizes and directs G3 to provide the Certificate to the Trust and its transfer agent, Alliance Trust Company ("Alliance").

The Farmer acknowledges that the Certificate and all information concerning the Farmer contained in it will be transmitted to and maintained by Alliance as the Trust's transfer agent. Accordingly, all information concerning the Farmer (including without limitation personal information) will be collected, stored and administered in accordance with Alliance's Privacy Policy which can be found at www.alliancetrust.ca/privacy and as required or permitted by law. The Farmer further authorizes and directs G3 to provide the Trust and Alliance with information regarding the volume of grain sold and delivered to G3 by the undersigned for the purpose of determining the undersigned's entitlement to trust units. The Trust is subject to certain trust reporting requirements prescribed under the Income Tax Act and the Farmer hereby authorizes the trustees of the Trust through Alliance to provide the information contained below to the Canada Revenue Agency as required to comply with such reporting obligations. Upon delivery of the Certificate, Alliance will contact the Farmer to confirm information required in order to issue trust units. The Farmer acknowledges and agrees that information regarding the trust units issued to the Farmer may be disclosed by Alliance to G3.
